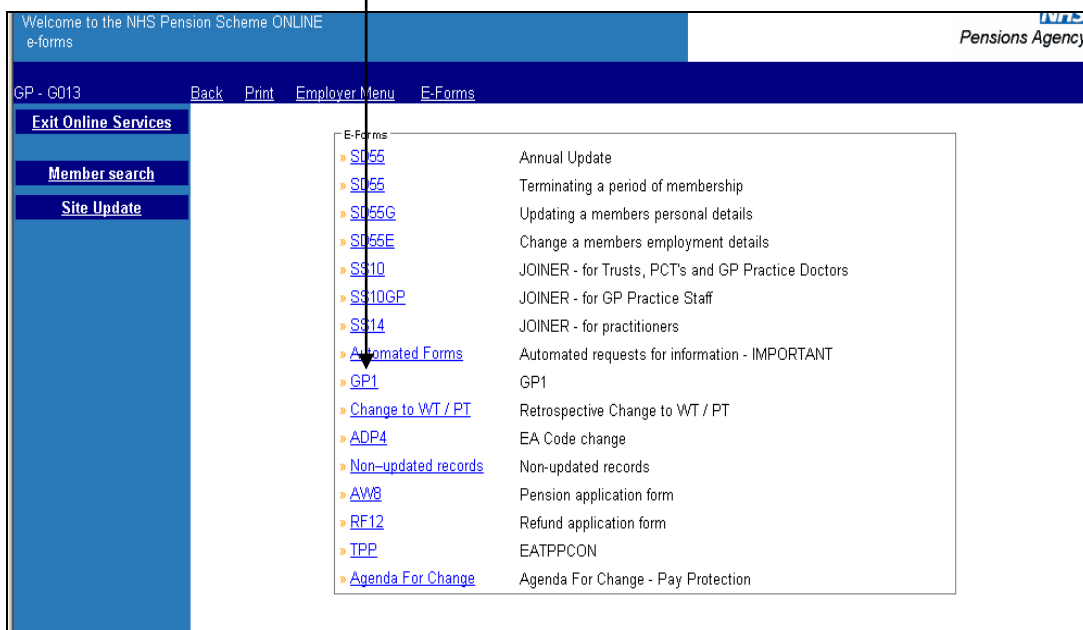


NHS Pensions Online Guide

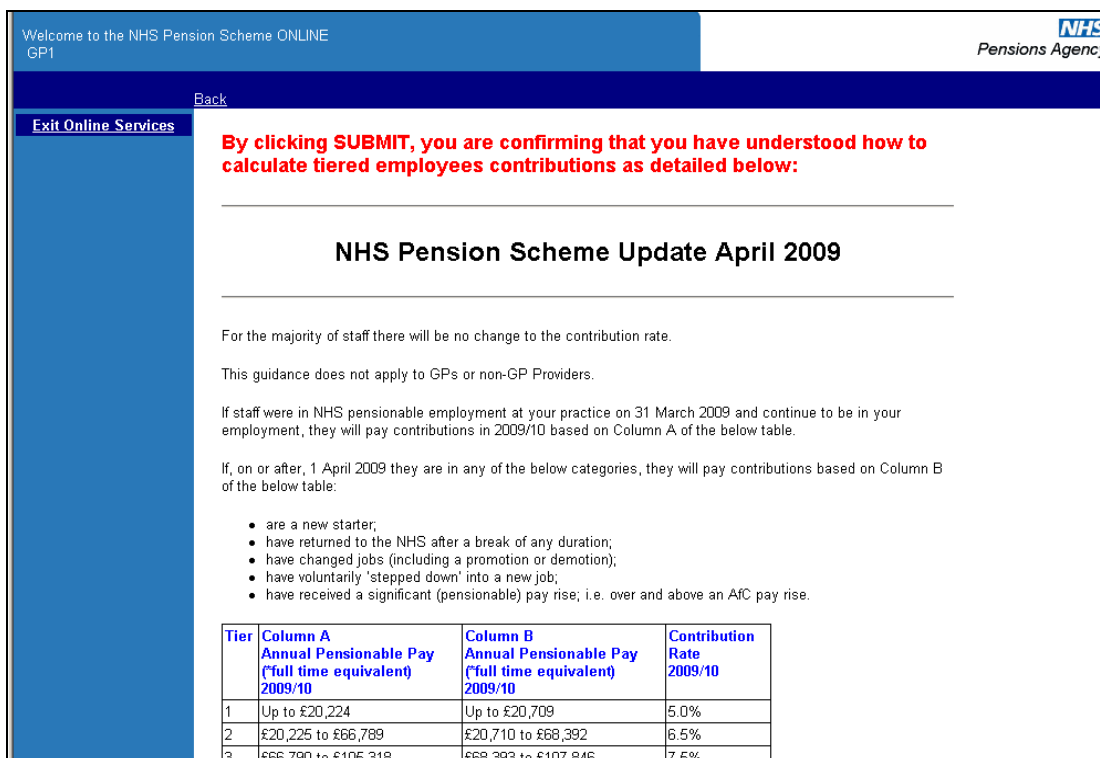
31. GP1 (GP Practices only)

Form GP1 is only available for use by GP Practices only, to advise NHS Pensions of the total amount of employee and employer contributions being paid each month.

The form can be found in the main E-Forms list but is only visible to GP Practices:



Once the link has been selected you will first see information on the deduction of tiered contributions, as follows:



By clicking “submit” at the bottom of the page you are confirming that you have read and understood this information.

GP1 - Microsoft Internet Explorer provided by Envision

For the majority of staff there will be no change to the contribution rate.

This guidance does not apply to GPs or non-GP Providers.

If staff were in NHS pensionable employment at your practice on 31 March 2009 and continue to be in your employment, they will pay contributions in 2009/10 based on Column A of the below table.

If, on or after, 1 April 2009 they are in any of the below categories, they will pay contributions based on Column B of the below table:

- are a new starter;
- have returned to the NHS after a break of any duration;
- have changed jobs (including a promotion or demotion);
- have voluntarily 'stepped down' into a new job;
- have received a significant (pensionable) pay rise; i.e. over and above an AfC pay rise.

The rules in respect of tiered contributions apply to members of both the 1995 section and the 2008 section of the Pension Scheme.
