1. Introduction

Members were welcomed to the meeting and apologies made for those unable to attend.

2. Department of Health update on the Future Operating Model

Ann McChesney and Justine Henson joined the meeting to provide an update on the future operating model.

3. Minutes of last meeting – 23rd September 2016

The minutes were agreed as a true record. The Chair explained that a summary of actions had been produced and that the majority had been worked on and closed since the last meeting, updates were provided to members.

4. National Customer Board update

The Chair provided an update from the National meeting on 11th November 2016, highlighting the following key points;

- Great progress on work with NHS Supply Chain, savings from regions £16m ahead of plan at £187m to end October 2016
- Working well together in a complex landscape, acknowledging the need for targeted stakeholder communications
- In discussion with colleagues at NHS Improvement on how to align agendas, roles and responsibilities with Customer Board maintaining a peer to peer support role
- Customer Board engagement through DH Stakeholder Advisory Group on FOM and input into specifications for Category Towers
- CCS dashboard and quarterly newsletter shared across Customer Board
- Excellent progress in Clinical Evaluation Team and support for key procurement initiatives
- Recognition of strong engagement between Clinical Reference Board and regional Customer Boards

5. Progress with Clinical Reference Board workplan; key priorities

5.1 **Standardisation project and pilot activity with the Ambulance Service and Acute Trusts** Sandy Brown provided an update on this pilot project. Key points included;

- There has been some excellent dialiogue between the acute trusts and ambulance service.
- Good support has been seen from the Ambulance Service national procurement group
- There is a lot of interest from other trusts in this project.

5.2 Summary of recent engagement with nursing community and active networks

Dee Roach fed back from the RCN regional event on 15th November aimed at procurement and clinical staff. Attendance was excellent and the event was very well received, covering some examples of good practice on the 'small changes, big differences' activity.
