28 Day Re-attendance Provider Report September 2017 for contract xxxxx/xxxx

This report provides details of 28 day re-attendance rates (28DR) at contract level for various time periods together with details of performer activity during the last 12 schedule months.

Any Band 1-3 FP17 which follows within 28 days of a previous Band 1-3 FP17 for the same patient at the same contract, is categorised as a 28 day re-attendance claim. Therefore, urgent treatment is not included and neither are patients who attended a different contract within 28 days. Where FP17s do not have a date of completion, e.g. where the patient has failed to return to complete the treatment, the date of acceptance is used.

The National (England & Wales) and individual contract rates in this report have been calculated by taking the number of 28 DR Band 1-3 FP17s divided by the total number of Band 1-3 re-attendance FP17s submitted.

The purpose of the report is to provide information that will enable contracts to manage re-attendance intervals.
