Regulation update

On 13 November 2019, we advised you that the regulations have been laid which extend the prototype agreement scheme until 31 March 2022.

We will be sending you your contract extensions in the New Year. You must sign and return the contract to continue under your prototype arrangements from April 2020.

Reminder: Year-End 2019/20

Year-end letters were sent out at the end of September and included an Annex B declaration for you to sign and send to your NHS England Local Dental Team. If you've not done this, please ensure you give this your attention as soon as possible.



Dental Quality and Outcomes Framework

No funding will be associated to the Dental Quality and Outcomes

Framework (DQOF) in 2018/19 or 2019/20. This decision was made by the

DCR programme and previously conveyed to practices in factsheets.

You will still need to collect data and you will still receive information about your achievement against the indicators.

BPS 2017 guidance on periodontal assessment

We've listened to your feedback about the new periodontal classification and how it should be handled with regards to the clinical pathway in the DCR programme.

Recording information within the clinical pathway and the risk assignment

You should:

- continue to use the clinical pathway as set out in the DCR software
- supplement the clinical record with local templates to record additional information (if necessary)
- override the generated periodontal RAG if you do not feel it is appropriate

Reviewing the clinical pathway

You should continue to review the clinical pathway against current clinical



guidelines at appropriate intervals. The new periodontal classifications and forthcoming revision of delivering better oral health are examples that need to be considered.

Performance management

To help you manage your contract, the following tools are available:

- monthly reports allowing you to manage your performance and contract activity. The reports can also help with managing your capitation lists and identify patients due to be removed.
- modelling tool enabling you to forecast your year-end position and identify areas to focus on. The tool is designed to help you meet your contract measures.
- exchange mechanism which allows the exchange of non-capitated activity for seeing additional patients.
- bulk transfer tool which enables you to move patients between performers as they join and leave a practice.

Full details of the reports and the exchange mechanism are included in Issue 10 of DCR News.

Bulk transfers
