Batch submissions - Account Identifier Document

This month we sent out communications informing you that from August 2022 pharmacy contractors will no longer need to print and submit a copy of your completed FP34C declaration.

You must continue to submit your FP34C declaration via the Manage Your Service portal (MYS) by the 5th day of the following month in which the supply was made.

You will also receive your Account Identifier Document from us each month for you to place inside your prescription bundle before returning it to us for payment.

Licensed Medicines - now available

For patients needing melatonin tablets, instead of using a Special, the following licensed products are now available:

- Adaflex 1mg tablets (AGB-Pharma) x 30
- Adaflex 2mg tablets (AGB-Pharma) x 30
- Adaflex 4mg tablets (AGB-Pharma) x 30
- Adaflex 5mg tablets (AGB-Pharma) x 30

For patients needing liothyronine 10microgram capsules, instead of using a Special, the following licensed product is now available:

• Liothyronine 10microgram capsules (Roma Pharmaceuticals Ltd) x 28

For patients needing Chloral hydrate 500mg/5ml oral solution, instead of using a Special, the following licensed product is now available:

 Chloral hydrate 500mg/5ml oral solution (Marlborough Pharmaceuticals Ltd) x 150ml

For patients needing Atorvastatin as an oral suspension, the following licensed product is now available:

 Atorvastatin 20mg/5ml oral suspension sugar free (Rosemont Pharmaceuticals Ltd)



Real Time Exemption Checking - Department for Work and Pensions rollout complete

The Department for Work and Pensions (DWP) functionality has been successfully rolled out to all pharmacies using Real Time Exemption Checking (RTEC).

This means pharmacies using RTEC can now check if a patient is eligible for

free NHS prescriptions against DWP exemptions.

More than 9,000 pharmacies are currently using RTEC. Pharmacies have reported that using RTEC saves staff time as patients do not need to complete the declaration on an EPS token when an exemption is found.

Before RTEC can be activated for an individual pharmacy, the pharmacy contractor must confirm that they agree to the terms of the RTEC user agreement. It is therefore recommended that all contractors complete this to avoid delays in their system supplier activating RTEC.

Quarterly New Medicines Service Data (NMS) returns not required for Q1 2022/23

Due to the pandemic, contractors were not required to submit their completed

<u>NMS</u> summary data to us in 2021/22. NHS England has been reviewing this data requirement and will advise in due course arrangements for later quarters in 22/23.

Endorsing Serious Shortage Protocols (SSPs)

What is an SSP?

If the Department of Health & Social Care (DHSC) decides there is a serious shortage of a specific medicine or appliance, they may issue a Serious Shortage Protocol (SSP).

Under an SSP, pharmacists have the power to dispense an alternative to a prescribed medication, without first having to contact the patient's GP.



Electronic Repeat Dispensing (eRD)
